Advantage® 3000 Respirators

The Advantage 3000 Full-Face Respirator incorporates MSA's global engineering expertise and is designed to meet NIOSH and EN standards.

For the utmost in convenience, the Advantage 3000 Respirator uses the same cartridges and filters as the Advantage 200LS Respirator.

The Advantage 3000 Respirator with its soft, pliable silicone facepiece, enhances worker performance through a new design that allows even lower breathing resistance and includes a standard noseclip that reduces fogging in low temperatures or high humidity conditions.

In addition, the wraparound polycarbonate facepiece lens has a scratch resistant coating and has been engineered to be optically correct, giving you superior visibility and peripheral vision. In short, the lens, which exceeds the performance requirements of ANSI Z87.1, eliminates distortion.

Donning the mask is made easier with MSA's new pre-adjustable straps. With the Advantage 3000 Respirator, you'll have the ability to set the position of the upper straps to receive a consistent fit, time after time. In addition, the preset upper straps prevent uncomfortable snags during donning and doffing, and also provide a tighter, more secure seal. Wearers also can choose the new European-style Advantage harness, which dons like a catcher's mask.

Cartridges and Filters

P100 or HE Filter is a high-efficiency filter (99.97% efficient against 0.3 micron particulates). This type of filter exceeds the EPA's recommended minimum filter efficiency (95%) to minimize exposure to mold spores.

P100 FlexiFilter with Nuisance Level OV Removal is a high-efficiency filter (99.97% efficient against 0.3 micron particulates). This filter also has the ability to remove Organic Vapors that fall below the Permissible Exposure Limit. This type of filter exceeds the EPA's recommended minimum filter efficiency (95%) to minimize exposure to mold spores.

GME-P100 is a combination cartridge with NIOSH approvals for use against Organic Vapors, Acid Gases, Ammonia and Methylamines, Formaldehyde, Hydrogen Fluoride and P100 (99.97% efficient against 0.3 micron particulates). This Cartridge is effective against chemicals found in most cleaning agents. This type of filter exceeds the EPA's recommended minimum filter efficiency (95%) to minimize exposure to mold spores.

OptimAir® 6A PAPR with OptiFilter® Cartridges



The OptimAir 6A Powered Air-Purifying Respirator (PAPR) provides respiratory protection by filtering contaminants from ambient air and providing a constant flow to a facepiece. It can be used with a family of filters and chemical cartridges for protection against particulates, toxic gases and vapors, or a combination of these hazards.

The OptimAir 6A includes a motor/blower module and rechargeable NiCad battery and is designed to operate for a full shift. It uses only two filters.

Applications include mold remediation, hazardous materials cleanup, asbestos and lead paint abatement, chemical processing, foundry, smelter and coke oven applications, and nuclear facilities work.

OptimAir® MM 2K PAPR with Type HE OptiFilter® XL Filter

The OptimAir MM 2K Powered Air-Purifying Respirator (PAPR) is designed for mold remediation and abatement. The PAPR filters particulates from ambient air and provides a constant flow of respirable air to the Advantage 3000, Ultravue or Ultra Elite Facepiece. The mask-mounted motor/blower with HEPA filter has a low profile design that enhances user maneuverability and simplifies decontamination.

The PAPR includes a small, lightweight, water-resistant nickel metal hydride (NiMH) battery pack that will operate for eight hours of continuous use. Weighing only 12.5 oz., the battery pack measures only 3"x 5"x 1". The low-profile unit fits close to the wearer's body. The sealed battery pack is water-resistant for easy shower decontamination. Another advantage: NiMH batteries do not have the "memory effect" associated with NiCad batteries. The standard Dual-Rate Battery Charger will recharge a fully discharged battery in less than three hours.
