Description

Removable full wrap visor attachments that can be field deployed and mounted to all sizes of ACH style helmets in order to protect the user's face from projectiles and debris that may be encountered in performing law enforcement, first response, and crowd control enforcement tasks.

General Information

The visor assembly includes a mounting adapter and polycarbonate-based shield and user instructions.

Two versions of faceshield will be available: A riot shield and military-style shield. Visors will be available in short (6-inch) or standard (8-inch) lengths. The short length shield will accommodate MSA Millennium® and Riot Control Gas Masks with no interference.

Visors are attached to all standard sizes of MSA commercial and military versions of ACH and TC 2000 Ballistic Helmets.

Visors are to be operable in the 2 positions: – fully-closed in the down position and fully open – and will have a positive stop in the down position. When in the up position, the visor will not interfere with visibility or the shouldering of a weapon.
